## QA-HEVET ERASMUS+ PROJECT:



Developing robust quality assurance systems is essential for both Higher Education Institutions (HEIs) and Vocational Education and Training (VET) Providers to develop high-quality and inclusive education and training and respond appropriately to labour market demands. Despite some similarities, there is currently no systematic exchange between the two systems. Therefore, the QA-HEVET project aimed to investigate the strengths, weaknesses and competitiveness of both quality frameworks, to develop common quality indicators, and to design practical digital instruments for assessing quality assurance.
